Human Resources: All teaching positions have been filled. Jamie Sandoval is the Director of HR and Operation. EP is searching for a Director of Academic Achievement who will replace the Assessment Director. The Director will develop the structure for and supervise the execution of a high quality, rigorous, data driven academic program.

EP Retirement Update: STRS has been reported and is up to date.

Teacher Certification: The data is effective as of January 2015

Special Education: Seneca continues to provide services to all our special education students at both our DL and HS academies.

WASC: Our one day mid-year review will take place March 25th, 2015. Our chairperson will be Gerry Catanzarite, Principal of Big Picture High School-Fresno. We are preparing our progress report that will be submitted on March 4th.

Community Relations: EP continues to keep open lines of communication with our authorizer East Side Union High School District. EP successfully completed our Fall Monitoring Visit for EAFLC and EP/CTC. We had 7 East Side Union High School District representatives as well as a county employee on our campus visiting classrooms, reviewing documentation and auditing teacher credentials. EP submitted the School Evaluation Framework and Monitoring binders before the due date.

Last month Ms. Reguerin was invited to be a part of the stakeholder committee that interviewed candidates to be appointed to the vacancy left by Magdalena Carrasco as Trustee of East Side Union High School District.

Ms. Reguerin also, participated as a chairperson in the Santa Clara County Immigration Reform at a Crossroads Regional Convening on February 11<sup>th</sup>.

Timothy O'connor from La Salle University visited our school and informed us about the program they are starting at the NHU campus. BUSCA will allow students to obtain an AA degree at low or no cost. They will hold informational sessions for our juniors and seniors.

Megan Taylor, the Founder of Cal Corps also visited our campus this month and is excited to start a partnership with us. Cal Corps wants to design teacher training and a support program for STEM teachers and will mentor them for six years.



On February 26th, Karen Martinez, Trustee of Alum Rock School District will be visiting our school. She is interested in exploring the possibility of Escuela Popular providing ESL classes to adults who are unable to attend our school.
